SGRC Assists the City of Waycross with Rehabilitation and Reconstruction of Substandard Housing

The City of Waycross was awarded \$611,113 in Community Development Block Grant (CDBG) funds to address substandard housing throughout the city. To date, the city has completed two rehabilitation units and one reconstruction. The construction contractor for all three units was Day Construction of Ambrose. The reconstruction consisted of the demolition of an existing dilapidated home and reconstruction of 1,190 square feet - 3 bedroom, 2 bath home for an elderly woman and her grandchild. One rehabilitation project consisted of a 1,400 square foot 3 bedroom and 2 bath home for a senior citizen.

SGRC Community Economic Development Division Reminds City and County Governments of CDBG Planning Time

The Georgia Department of Community Affairs will be accepting applications for its Annual Competition for 2024 Community Development Block Grants (CDBG) on April 1, 2024, and the time to begin planning those applications is NOW! Threshold requirements implemented by DCA have necessitated getting an early start on CDBG applications in order to be eligible to submit an application.

CDBG funds are federal dollars allocated to the State of Georgia by the Department of Housing and Urban Development (HUD) and are earmarked to benefit primarily low to moderate income people. In fact, the beneficiaries of a CDBG project must be at least 70% low to moderate income.

Examples of eligible public facilities and improvements activities include, but are not limited to: water and sewer facilities, flood and drainage improvements, streets, and neighborhood revitalization. Other activities may include the development of shelters/facilities for homeless, elderly, mentally ill, abused, and impaired persons. Public facility activities may also include the development of medical, community, senior, and handicapped centers, or centers for literacy training.

For the 2024 CDBG application round, the maximum funding amount for a single-activity public facilities grant is \$1,000,000. Local governments are required to provide a 5% cash match of amounts from \$300,001 to \$750,000 in CDBG funds, and 10% cash match of amounts from \$750,001 to \$1,000,000 (not required for single-activity neighborhood revitalization grants). Multi-Activity projects are eligible for up to \$1,250,000 in CDBG funds; a 15% cash match is required for amounts of \$1,000,001 or more.

Development of a quality, competitive, and eligible CDBG application is time consuming, and therefore the process should begin immediately. WorkSource Southern Georgia Staff Attend Georgia Chambers 2023 Rural Prosperity Forum

On Wednesday, July 26th, Amy Jones, Business Services Program Manager, and Savannah Bennett, Business Services Program Coordinator, attended the Georgia Chamber's 2023 Rural Prosperity Forum

in Tifton. The annual event, held at the Georgia Museum of Agriculture & Historic Village, focused on the Future of Rural Workforce by providing data, local panel speakers sharing best practices, student opportunities, and healthcare workforce solutions.

Data shared during the event included a stark reality that 3.2 million working-age Georgians are not working. Additionally, the top three (3) industries for Georgia are Education, Healthcare, and Tourism. These fields are traditionally staffed by women, and childcare has been a massive barrier for working mothers. Childcare workers are also mainly female and many households weighed the cost of childcare versus the income that could be made by working. As a result, many women made the choice to leave the workforce, during the pandemic.

SGRC Planning Division Announces it's Time to Start Planning for Rural Zone Designation

It is time to start planning for the Rural Zone Designation's August 2024 deadline. To be eligible, communities must have a population of 15,000 or fewer, have a concentration of historic commercial

structures, and must be economically distressed as defined by the Georgia Department of Community Affairs. Additionally, communities should comply with the state requirements, submit a feasibility study or market analysis, and must submit a master plan or strategic plan.

Interested communities must perform a Downtown SWOT Analysis, document the current state of the downtown infrastructure,

discuss and document the distressed areas of downtown, list the goals to achieve the revitalization outcomes, and determine the type of businesses to attract.

The Rural Zone program targets rural downtown areas by offering economic development incentives when local economic conditions have been adversely impacted. It also adds in retail opportunities, which were once excluded from job tax credits. Further, multiple sources can benefit – for instance, a single new coffee shop might provide job tax credits for the local business owner and an investment and rehabilitation credit to a downtown investor.

The Job Tax Credit (JTC) will be \$2,000 per new full-time equivalent job per year, up to 5 years, and not to exceed \$40,000 per year. At least two net, new full-time equivalent jobs must be created to qualify. This credit is for the small business owner who opens a storefront within a designated Rural Zone and creates jobs.

The Investment Credit is equivalent to 25% of the purchase price, not to exceed \$125,000 total or \$25,000 per year. At least two net, new full-time equivalent jobs must be created and maintained to qualify for the investment credit. This credit is for investors who purchase a building within the designated Rural Zone.

The Rehabilitation Credit is equivalent to 30% of the qualified rehabilitation, not to exceed \$150,000 total or \$50,000 per year. At least two net, new full-time equivalent jobs must be created and main-tained to qualify for the rehabilitation credit. This credit offsets development costs associated with rehabilitating a property within a designated Rural Zone.
