

Southern Georgia Regional Commission Receives Health and Wellbeing Incentive Grant

The Southern Georgia Regional Commission (SGRC) has been selected by the Georgia Municipal Association (GMA) to receive an Employee Health Promotion and Wellbeing Grant. GMA awards this grant to recipients statewide to promote worksite programs that are designed to enhance the health and wellbeing of employees and family members.

Grant awards are made to members of the Georgia Municipal Association-Georgia Municipal Employee's Benefit System (GMA-GMEBS) Life and Health Insurance Fund, underwritten by Anthem Blue Cross Blue Shield of Georgia, and are based on an organization's commitment to employee health and demonstrated collaboration with other community groups and organizations engaged in health promotion. As part of the grant process, each grant recipient designates a Health Promotion Champion to develop a workplace health promotion action plan and to attend a Local Government Risk Management Services' (LGRMS) Health Promotion Champion Training workshop. Rachel Strom has been named the SGRC's Health Promotion Champion for Fiscal Year 2022.

Workplace wellbeing programs have a demonstrated track record of improving employee health and quality of life while also reducing medical claims and improving workplace morale. GMA offers wellbeing services to all member organizations through LGRMS, a not-for-profit agency operated jointly with the Association County Commissioners of Georgia. LGRMS-Health Promotion Services (HPS) along with GMA is committed to helping local governments engage in building comprehensive health promotions and wellness programs.

"We are pleased that GMA recognizes our interest in overall employee wellness," stated Rachel Strom, Health Promotion Champion. "This grant will assist us in implementing programs designed to educate, challenge, and encourage employees to live healthier lifestyles." Employees will be offered a confidential health assessment program, on site education opportunities, and a support system through meetings and social media.

The GMA-GMEBS is available to all GMA members. Currently, several cities, authorities, and regional commissions participate in the health plan.

City of Douglas and Coffee County Hold Groundbreaking Ceremony for New Adult Behavioral Health Facility

On November 3, 2021, the City of Douglas and the Coffee County Commission held a groundbreaking ceremony for the new \$1,188,400 Coffee County Adult Behavioral Health Facility on West College Park Drive in Douglas. This was made possible through a Community Development Block Grant (CDBG) written by the SGRC's Community and Economic Development Division, as well as participation from the City, County, Unison Behavioral Health, and Coffee County Regional Medical Center.

Present were Mayor Tony Paulk, City Commissioner Kentaiwon Durham, City Manager Charles Davis, Unison Board Member JoAnne Lewis, Unison CEO Dr. Glyn Thomas, Coffee Regional Medical Center CEO Vicki Lewis, GA Department of Community Affairs' Kelly Lane, SGRC's Michael Jacobs, and others.

Once completed, in approximately six months, this facility will provide outpatient services for adults with mental health illnesses and substance abuse disorders from not only the City of Douglas & Coffee County, but also from area counties. This facility will benefit 951 people, of which 98.53%, or 937, are low to moderate income.

DCA Commissioner Christopher Nunn Recognizes Local CDBG Recipients and Officials

Georgia Department of Community Affairs (DCA) Commissioner Christopher Nunn attended the SGRC Area Officials Appreciation Dinner at The Farm in Adel on October 26 and recognized local Community Development Block Grant (CDBG) recipients which included the City of Adel, the City of Broxton, the City of Douglas, Bacon County, Cook County, and Ware County. Also recognized were the Tift County Development Authority for a \$500,000 OneGeorgia Equity Award, the City of Homerville for RuralZone Designation, and the City of Waycross and Cook County for PlanFirst Designation.

Governor Brian Kemp announced in September that sixty local governments would be awarded \$43 million in CDBG funds to help improve their communities. The SGRC Community and Economic Development Division prepared six of the seven awarded CDBG applications in this region.

SGRC- Local Government Services Division Announces Due Dates for Surveys and Reports

Local governments and authorities in Georgia have a series of annual reporting requirements. In order to maintain eligibility for grant funding and to be in compliance with the performance standards

established in the Regional Plan, the information to the right and on the next page regarding financial, service delivery, and administrative practices is required to be submitted annually. In addition to updating local government contact information, this also includes the Government Management Indicators (GOMI) Survey and Report of Local Government Finance (RLGF) for all local governments. The Hotel/Motel Tax Report is only required for local governments who impose a Local Hotel-Motel Excise Tax. Lastly, the Debt Issuance Report is due within 60 days of debt issuance by a local government.

SGRC Transportation Division Shares Valdosta-Lowndes MPO Unified Planning Work Program Update


The Valdosta-Lowndes Metropolitan Planning Organization's (VLMPO) Unified Planning Work Program (UPWP) is being updated for Fiscal Year 2023. The UPWP is an annual document that lists the planning activities for the upcoming fiscal year and provides fiscal information regarding how MPO funds will be spent to help achieve the vision, goals and objectives of transportation initiatives and planning processes of the Valdosta-Lowndes MPO.

The UPWP has five main categories that the activities to be undertaken will address. These categories are: Program Administration, Public Involvement, Comprehensive Planning/Research, Transportation Systems Planning, and the Business Plan. The first four categories listed focus on planning activities and the parties responsible for carrying out the initiatives. Within each of these categories are subcategories that provide detailed projects and administrative tasks to be completed. These detailed projects and daily activities are focused on creating and maintaining a safe, efficient transportation network as well as transit activities. This can include an array of projects, from analyzing transit data to preparing

for electric vehicle and smart infrastructure technology. The last category, the Business Plan, provides information about current unfunded projects and future planning activities that are integral to carrying out the core function of the VLMPO.

The VLMPO has been on schedule with implementing and completing various transportation initiatives and projects from the Fiscal Year 2022 UPWP. For Fiscal Year 2023, VLMPO staff, committees and planning partners will continue to focus on implementing various transportation initiatives and creating key planning documents that will help to increase the quality of life in the VLMPO area through maintaining a reliable transportation network.

As a result of the 2000 Census, in 2003, the VLMPO was established pursuant to federal law to address transportation planning within Lowndes County and the urbanized portions of Berrien, Brooks, and Lanier Counties, including

the municipalities of Dasher, Hahira, Lake Park, Ray City, Remerton, and Valdosta.

The VLMPO is staffed by the Southern Georgia Regional Commission's Transportation and Environmental Department to perform the day-to-day functions of transportation planning activities within the VLMPO planning area. The Policy Committee (PC), comprised of elected officials and other decision makers from each participating jurisdiction, provides final decision-making authority and leadership

for the VLMPO. The Technical Advisory Committee (TAC) and Citizens Advisory Committee (CAC) provide insightful input to the Policy Committee on transportation issues.

In 2003, Governor Purdue designated the Southern Georgia Regional Commission (SGRC), an 18-county regional planning and intergovernmental coordination agency, to host the VLMPO and provide staff support to this planning effort. This legislation and required agreements, such as the Memorandum of Understanding, ensures that a "continuing, cooperative and comprehensive" (referred to as "3-C") planning process involving federal, state and local agencies, as well as citizens and other affected stakeholders is upheld.

SGRC Small Business Lending Program Assists One Stop 5, Ray City with RLF Loan

Neel Patel has owned and operated One Stop 5 at 925 Patten Avenue in Ray City for nine years. He has successfully built a strong customer base with repeat customers in a small town that has little competition. Two jobs were created.
