The Southern Georgia Regional Commission (SGRC), as administrative entity for the Southern Georgia Workforce Development Board (WDB), is requesting proposals from qualified organizations for One-Stop Operator (OSO) duties and functions. Primary responsibilities will be the coordination of the service delivery of required One-Stop partners and service providers within the One-Stop and affiliate sites in the Southern Georgia Workforce Development Area (WDA). Programs will be operated under WIOA guidelines.

The Southern Georgia WDA consists of the counties of Atkinson, Bacon, Ben Hill, Berrien, Brantley, Brooks, Charlton, Clinch, Coffee, Cook, Echols, Irwin, Lanier, Lowndes, Pierce, Tift, Turner and Ware. The Southern Georgia WDA will have one Comprehensive One-Stop Center (COS) which will be located in Valdosta, GA (Lowndes County). The Georgia Department of Labor (GDOL) Valdosta Career Center has been designated by the Southern Georgia WDB to serve as the COS facility. The OSO will be located at this facility. There are three additional affiliate sites located in Douglas, Tifton and Waycross. The OSO will have responsibility in these affiliate sites as well.

A bidder's conference is scheduled for Thursday, April 23, 2020 (see time on the RFP Schedule). The bidders conference will be held via conference call.
