These targets are set annually using data driven approach and five-year rolling averages. The targets must demonstrate constant or improved performances. After presenting the resolution Chair Paige Dukes asked for any additional questions from the committees and guest. With no additional question Steve Lasseter made a motion to approve with a second from Bill Slaughter. The motion carried.
