#### Agenda Item #1 – Call to Order

Mr. Griffin called the meeting to order at 3:03 pm.

#### Agenda Item #2 - Introductions/Roll Call

#### A. Review of Committee Attendance

Mr. Griffin asked those present to introduce themselves and state their affiliation with the committee.

#### Agenda Item #3 – Approval of Regular Meeting Minutes

Mr. Griffin asked for approval of the minutes from September 1, 2015. The minutes were approved by acclamation.

#### **Agenda Item #4-New Business**

#### A. TAC Election of Officers (Chair, Vice Chair)

**Action: Elect Officers**

## **B.** FY2016 Amended UPWP and Budget- Resolution FY2016-3 Action: Recommendation/ Vote for Approval

Mr. Hull started by explaining the budget funding table located on page 23 of the agenda packet to the committee. He reminds the committee that back in May the committee adopted the FY2016 budget; however, two things were left out. First, Congress only approved 2/3 of the annual budget, so we could not budget our full amount. Second, we also did not budget for the unexpended federal funds from FY2015, which cannot be budgeted until we close out our books for FY2015. We now have a full allocation so we need to amend the FY2015 carryover funds and the FY2016 federal allocation. Mr. Griffin asked if there were any changes in the programs by changing the dollar amount. Mr. Hull responded that the public participation line item and staff education has been added to. Mr. Rawls asked if the funds were automatically available to the SGRC, and if they are why are we voting on it. Mr. Hull responded, in order for the GDOT and Federal principals to stay in place, they want a formal action to make sure it was approved. Mr. Tucker stated that the amount is quite a large carryover. Mr. Hull replied that there have been larger amounts carried over in the past, but this is the last year that we will have carryover funds. We will have to apply for left over funds and compete with 15 other cities in the state. We will be spending almost 100% of our money this year. Mr. Branham asked what amount was allocated to the Transit plan. Mr. Hull replied that FTA funding was allocated towards that and we are currently working with the consultant to move forward with it. No more questions followed; Mr. Seager made a motion to recommend the FY2016-3 Resolution, Mr. Sable made a motion to the second. The vote was unanimous: the motion carried.

#### C. FY2017 5303 Grant Application- Resolution FY2016-4

#### **Action: Recommendation/Vote for Approval**

Mr. Hull explained that to apply for the amount on the right half of the budget table, the FTA 5303 funds, there has to be a formal resolution. He further explained that the SGRC is not anticipating a change in the amount and a recommendation must be made to the PC to move forward. Mr. Rawls made a motion to approve and recommend the FY2016-4 Resolution, Mr. Branham seconded the motion. The vote was unanimous; the motion carried.

#### D. Amend Memorandum of Understanding (Financial) Action: Recommendation/ Vote for Approval

Mr. Hull explained that discussions had been made about the match portions that Lowndes and Valdosta pay to SGRC. Mr. Hull stated that a few local jurisdictions currently do not pay any match funds so we are proposing to change the split of the local match. For the FHWA funds, we are proposing that the RC pay 4% of the 20% required match and that will cover the smaller cities and counties that do not pay any match funds. Lowndes and Valdosta will be responsible for 8% each. For the 5303 funds, we are proposing that the RC pay 2% of the local match. Valdosta and Lowndes Co. will pay 4% each. This will be effective FY2017. Mr. Hull also explained the following changes: anytime in the future that a consultant is hired to conduct a special study, the study will be paid for by Valdosta and Lowndes Co. at 50% each. There is also a stipulation asking that the RC, Valdosta and Lowndes Co. use written correspondence concerning the funding proposed and expected from each local government for the functions of the MPO. Mr. Branham made a motion to approve the amended MOU; Mr. Cason seconded the motion. The vote was unanimous; the motion carried.

# E. Special Presentation- Overcoming Public Participation Apathy Community Transportation Association of America Action: Discussion Only

Mr. Hull notified the committee that the SGRC applied for a grant from Community Transportation Association of America and was selected. He then introduced Ms. Janice Lorenz, who is from CTAA. Ms. Lorenz asked the committee questions concerning their thoughts on public participation and what they wanted to see happen with transportation in this area. A discussion ensued concerning the topic.

#### Agenda Item #5 – Staff Update

#### A. FY2017 Budget

Mr. Hull stated that the language used in the FY2017 draft budget that the committee has received via email will change.

#### **B.** Federal Funding Update

Congress has released a new proposal named FAST ACT. Ms. Ballard asked if this proposal extends the Highway Trust Fund. Mr. Hull replied that it does extend it through 2020.

#### C. Shuttle Pilot Program

Mr. Dillard notified the committee that the pilot program is seeing an upward trend and that the hours of operation have been extended. Mr. Tucker asked if the geographic locations of the riders were known. Mr. Hull replied that we know the stops that people get on and off, but not the location that they are coming from.

#### D. Amendment to 2040 TVP

Mr. Hull notified the committee that the 2040 TVP will be amended due to new information that Valdosta and Lowndes Co. have concerning the projects and the changes will also go through a public comment period again.

#### E. GAMPO Update

Mr. Hull notified the committee that the GAMPO will become a nonprofit and he has been elected as the chairman of the organization.

#### Agenda Item #6 - Privilege of the Floor/Public Comment

Ms. Tooley asked if there is a record of the number of people who get on the shuttle because she does not believe that a lot of people know about it. Mr. Branham asked Ms. Lorenz about public-private partnerships that could be used for transportation purposes. Ms. Lorenz explained a program in Mississippi, where Enterprise is allowing the lease of their vehicles for employees to get to work. Ms. Tooley mentioned that it may be a good idea to work with the hospital to help children/families with healthcare access.

Mr. Fletcher called the meeting to order at 9:01 am.

#### Agenda Item #2 – Introductions/Roll Call

#### A. Review of Committee Attendance

Mr. Fletcher asked those present to introduce themselves and state their affiliation with the committee.

#### Agenda Item #3 – Approval of Regular Meeting Minutes

Mr. Fletcher asked for approval of the minutes from September 2, 2015. Mr. Collins made a motion to approve the minutes. Ms. Little seconded the motion. The vote was unanimous; the motion carried.

#### **Agenda Item #4-New Business**

#### A. TAC Election of Officers (Chair, Vice Chair)

**Action: Elect Officers** 

Mr. Fletcher asked the committee if they would like to nominate a new Chair and Vice Chair or if they would like the positions to stay as is. The committee agreed that the positions were fine as is. Mr. Collins made a motion to remain the Vice Chair and for Mr. Fletcher to remain the Chair. Mr. Fletcher seconded the motion. The vote was unanimous; the motion carried.

### **B.** FY2016 Amended UPWP and Budget- Resolution FY2016-3 Action: Recommendation/ Vote for Approval

Mr. Hull started by explaining the budget funding table starting on page 22 and the process of amending the UPWP to the committee. He continued explaining that the UPWP is amended this time of year to bring in our prior year carryover funds. The carryover funds are only federal dollars, there are no local dollars. Whenever we carryover federal funds we need to show that there is a local match associated with it. Congress had not fully appropriated our fiscal year 2016 allocation and we were asked to only approve 2/3 of our full year allocation. Now that Congress has fully appropriated our funding, we are asking to amend our UPWP by adding these funds to reflect the change. Mr. Fletcher made a motion to recommend Resolution FY2016-3 to the Policy Committee. Mr. Collins seconded the motion. The vote was unanimous; the motion carried.

#### C. FY2017 5303 Grant Application- Resolution FY2016-4

#### Action: Recommendation/ Vote for Approval

Mr. Hull explained that to apply for the amount on the right half of the budget table, the FTA 5303 funds, there has to be a formal resolution. He further explained, that the SGRC is not anticipating a change in the amount and a recommendation must be made to the PC to move forward. Mr. Thomas made a motion to recommend the FY2016-4 Resolution to the PC. Mr. Collins seconded the motion. The vote was unanimous; the motion carried.

#### D. Amend Memorandum of Understanding (Financial)

#### Action: Recommendation/ Vote for Approval

Mr. Hull explained that discussions had been made about the match portions that Lowndes and Valdosta pay to SGRC. Mr. Hull notified the committee that a few local jurisdictions currently do not pay any match funds so we are proposing an amendment to the MOU to change the split of the local match. For the FHWA funds, we are proposing that the RC pay 4% of the 20% required match and that will cover

the other cities and counties that do not pay any match funds. Lowndes and Valdosta will be responsible for 8% each. For the 5303 funds, we are proposing that the RC pay 2% of the local match. Valdosta and Lowndes Co. will pay 4% each. This will be effective FY2017. Mr. Fletcher explained that there had been some discussion from his office concerning smaller municipalities that do not pay a match but are voting in the committees and this is Regional Commission's way of resolving that issue. Mr. Fletcher stated that it allows us to pay less and also gives the smaller governments a sense of ownership. Mr. Collins stated that there may need to be caution in doing this because in order for this to be a real change you will have to reduce overhead or give something up so look for that when budgeting. Mr. Hull also explained other stipulations in the MOU; anytime in the future that a consultant is hired to conduct a special study, the study will be paid for by Valdosta and Lowndes Co. at 50% each and that the RC, Valdosta and Lowndes Co. use written correspondence concerning the funding proposed and expected from each local government for the functions of the MPO. Mr. Fletcher made a motion to approve amending the MOU; Mr. Collins seconded the motion. The vote was unanimous; the motion carried.

#### Agenda Item #2 – Introductions/Roll Call

#### A. Review of Committee Attendance

Mr. Gayle asked those present to introduce themselves and state their affiliation with the committee.

#### Agenda Item #3 – Approval of Regular Meeting Minutes

Mr. Gayle asked for approval of the minutes from September 2, 2015. Mr. Slaughter made a motion to approve the minutes. Mr. Hanson seconded the motion. The vote was unanimous; the motion carried.

### B. FY2016 Amended UPWP and Budget- Resolution FY2016-3 Action: Recommendation/ Vote for Approval

Mr. Hull started by explaining the budget funding table starting on page 22 and the process of amending the UPWP to the committee. He continued explaining that the UPWP is amended this time of year to bring in our prior year carryover funds. This year is unique because Congress had not fully appropriated our fiscal year 2016 allocation and we were asked to only approve 2/3 of our full year allocation. Now that Congress has fully appropriated our funding, we are asking to amend our UPWP by adding these funds to reflect the change. The carryover funds are only federal dollars, there are no local dollars. However, when we carryover federal funds we need to show that there is a local match associated with it. Ms. Cribb asked if the local amount on the resolution is correct. Mr. Hull responded that yes, there is a second handout with the correct amount. Ms. Cribb clarified that the separated sheet of the resolution replaces the one in the packet. Mr. Hull stated that is correct. Mr. Gayle asked for a motion to approve the amendment. Mr. Hanson made a motion to approve Resolution FY2016-3. Mr. Slaughter seconded the motion. The vote was unanimous; the motion carried.

#### C. FY2017 5303 Grant Application- Resolution FY2016-4

**Action: Recommendation/Vote for Approval** 

Mr. Hull explained that to apply for the amount on the right half of the budget table, the FTA 5303 funds, there has to be a formal resolution. He further explained, that this 5303 Grant application is for FY2017, and the SGRC anticipates this funding to be close to the FY2016 amount. This resolution will also be passed by the Regional Commission counsel. Mr. Hanson made a motion to approve the FY2016-4 Resolution. Mr. Schindler seconded the motion. The vote was unanimous; the motion carried.

#### **D.** Amend Memorandum of Understanding (Financial)

**Action: Recommendation/Vote for Approval** 

Mr. Hull explained that discussions had been made about the match portions that Lowndes and Valdosta pay to SGRC. Mr. Hull notified the committee that a few local jurisdictions currently do not pay any

match funds so we are proposing an amendment to the MOU to change the split of the local match. For the FHWA funds, we are proposing that the Regional Commission pay 4% of the 20% required match and that will cover the smaller cities and counties that do not pay any match funds. Lowndes and Valdosta will be responsible for 8% each. For the 5303 funds, we are proposing that the RC pay 2% of the local match. Valdosta and Lowndes Co. will pay 4% each. This will be effective FY2017. Mr. Hull also explained other stipulations in the amended MOU; anytime in the future that a consultant is hired to conduct a special study, the study will be paid for by Valdosta and Lowndes Co. at 50% each and that the Regional Commission, Valdosta, and Lowndes Co. use written correspondence concerning the funding proposed and expected from each local government for the functions of the MPO. Mr. Hanson asked if the 5303 funds were limited to rural transit. Mr. Hull responded no, these funds are used for metropolitan planning. Mr. Davenport asked if this agreement obligates the city or county to fund the MPO based on what the policy committee sets. Ms. Cribb responded no, it just asks that you let us know what has been put in the city or county budget for the match for the MPO so that in the case of a different amount than what is passed by the policy committee, we are informed of that. Mr. Hanson asked how we can effectively carry this out, when number three says we shall pay 50% each, so how can we budget something differently. Mr. Hanson stated that "shall" sounds pretty specific; however, I do not think it is a big factor because the city and county will only reimburse SGRC for what they actually spend. Ms. Cribb stated that was not the intention of the RC, we are just trying to clarify the process and communication part of it. Mr. Slaughter suggested that language be added that the 50% match is the budget that the policy committee adopts. Mr. Hull clarified that at the end of Item 3 & 4 add "as adopted in the UPWP by the PC." Mr. Slaughter agreed. Mr. Gayle asked for a motion to approve the amended MOU. Mr. Slaughter made a motion to approve the amended MOU with the statement "as adopted in the UPWP by the Policy Committee" added to Items 3 & 4. Mr. Hanson seconded the motion. 





#### **RESOLUTION TO Amend the FY2015-2018 Transportation Improvement Program**

WHEREAS, in accordance with the U.S. Bureau of the Census officially designated Urbanized Area Boundaries established May 1, 2002; and

WHEREAS, the Southern Georgia Regional Commission (SGRC) has been designated by the Governor of Georgia as the Metropolitan Planning Organization (MPO) for the Valdosta-Lowndes Urbanized Area in accordance with Federal requirements of Title 23, Section 134 of the United States Code to have a Cooperative, Comprehensive and Continuous transportation planning process; and

WHEREAS, the MPO will conduct federally-required transportation planning activities that will improve the transportation system and help coordinate the area's future growth within the area bounded, at minimum, by the existing Urbanized Area plus the contiguous area expected to become urbanized within the next 20 years; and

WHEREAS, the MPO is required through the Fixing America's Surface Transportation Act (FAST Act) to incorporate a four year horizon for the TIP, develop an annual listing of obligated projects (including bicycle and pedestrian facilities or investments), provide better visualization techniques regarding plans or projects to enhance the accessibility of plans by posting electronically or otherwise make available for public review as well as implementing new consultation processes and assessing potential environmental impacts of such plans to develop mitigation measures to minimize impacts (Section 450.322(f)7).

NOW, THEREFORE BE IT RESOLVED, that the Valdosta-Lowndes Metropolitan Planning Organization's Policy Committee amends the FY2015-2018 Transportation Improvement Program as required by Title 23 U.S.C. 134 Section 450.324 and Title 49 U.S.C. 5303; and that the FY2015-18 Transportation Improvement Program is consistent with the 2040 Transportation Vision Plan.
