# Introduction

Fiscal Year 2017 was a year of implementation and study for the Valdosta-Lowndes Metropolitan Planning Organization (VLMPO). The VLMPO staff carried out the implementation of the 2040 Transportation Vision Plan through plans that provide information to local decision makers about transportation improvements and working with our planning partners to implement projects for the traveling public.

In FY2016, the VLMPO studied public transit options for the region and truck traffic issues in Downtown Valdosta. In FY2017, the VLMPO worked with local partners to review and implement the recommendations from these consultant-led studies. The VLMPO has worked with local partners to inform the public and decision makers about the national and state award-wining success of the Pilot Shuttle Program and how that can translate into a permanent public transit system for the community. The Valdosta-Lowndes County Chamber of Commerce has taken the leadership role of proposing a new alternative for truck traffic in Valdosta, including working with leadership from the Georgia Department of Transportation (GDOT) to study these recommended alternatives in detail to determine their feasibility.

The VLMPO in partnership with the City of Valdosta completed a Traffic Signal Optimization Study that once all of the recommendations are fully implemented will result in a 35:1 benefit-cost ratio and the project will pay for itself every 7.2 workdays.

The leaders of the Valdosta and Lowndes County communities have also worked with the VLMPO and SGRC to begin the discussion of implementing a regional transportation sales tax that may provide more than \$513 million for transportation throughout the region.

# **MPO** Administration


The VLMPO staff continued its award winning, nationally recognized planning efforts in FY2017. Staff continues to maintain an active role in local, state and national organizations that benefit the Valdosta and Lowndes County area by bringing national best practices in transportation planning to our community.

Staff participates in the Transportation Research Board's Metropolitan Policy, Planning, and Process Committee, and co-chairs its' subcommittee on Transportation in Military Communities. In FY2017, staff has continued to serve on the National Cooperative Highway Research Program 08-36/Task 140 Committee to Assess Actual Transportation Impacts of the 2005 BRAC Decisions. Staff are also active on the Association of Metropolitan Planning Organizations Policy Committee, the Georgia Chapter of the American Planning Association (current President), as well as the Georgia Association of MPOs Board of Directors (current Chairman). Staff maintains involvement in several local civic organizations like the Valdosta Civic Roundtable where stakeholders often meet to discuss various community development and transportation related issues.

The VLMPO received a 2017 National Association of Development Organizations Innovation Award for the Valdosta and Lowndes County Complete Streets Suitability Report. The VLMPO also received the Association of Metropolitan Planning Organizations Outstanding Achievement Award for its 2040 Transportation Vision Plan and Common Community Vision Report.

The VLMPO staff was invited to speak about the Pilot Shuttle Program at the National Association of Development Organization and the Georgia Transit Association in FY2017. Staff also presented information about stakeholder engagement during the development of the 2040 Transportation Vision Plan at the 2017 TRB National Transportation Planning Applications Conference. During the 2016

AMPO National Conference and the Ohio-Kentucky-Indiana Regional Planning Conference, VLMPO staff presented information about the challenges facing Downtown Valdosta as it relates to mitigating truck traffic.



# MPO Public Participation

The VLMPO strives to be an organization that proactively gathers public input for transportation projects and inform the public of various transportation planning efforts going on throughout the community. To assist in this effort, the VLMPO utilizes its Participation Plans Policies, Strategies and Techniques to engage and inform the public throughout the year.

In FY2017, the VLMPO adopted an amendment to the Participation Plan that implements new best practices and improves communications methods for public engagement. With an increased focus on performance measurement throughout the MPO planning process, the VLMPO started an update to the Participation Plan in FY2017 that will help the VLMPO staff to better quantify the public engagement and outreach efforts undertaken by the staff. The VLMPO staff will continue to work on these efforts in FY2018.

# Title VI Annual Report

As required by the VLMPO Title VI Compliance Plan, included in this report is the Annual Report on Title VI activities undertaken during the past year by the VLMPO.

The VLMPO has not had any Title VI complaints and there have been no changes to the Title VI Plan in FY2017.

The VLMPO staff attended webinars in FY2017 on the topics of 'Incorporating Context Sensitive Solutions and Environmental Justice to Enhance Livability' and 'Integrating Equity into Regional Transportation Planning'

## Limited-English Proficiency Plan

As a recipient of federal funds, the VLMPO is required to evaluate the services and products we provide for use by individuals who may

speak English less proficiently. The VLMPO reviews data annually to measure this population in Lowndes County. The Participation Plan includes data from the US Census Bureau 2005-2009 American Community Survey, which is reviewed in the table below with data from the 2011-2015 American Community Survey.

Based on previous year data, the trend shows that both locally and nationally, more residents may have a Limited English Proficiency (LEP). The VLMPO will continue to use our LEP Plan to address the needs of these populations in our region.

## PP Performance Measures

When the VLMPO Participation Plan was adopted in 2011, it included performance measures that would be reviewed annually to evaluate how effective the VLMPO is at engaging the public. Included here are the performance measures, as well as an indication of whether this measure has increased, held steady, or decreased in the last year; an indication of the effectiveness of our public participation efforts. The VLMPO has recently begun the process to better quantify these performance measures and will have new performance measures ready for implementation in FY2018.

Strategy 1: Raise public awareness and understanding of the transportation planning process including the functions,

responsibilities and programs of the MPO and identify how interested citizens can become involved.

#### Performance measures:

- Number of public meetings. Hosted 3 open houses for the FY15-18 Transportation Improvement Program (TIP)/2040 Transportation Vision Plan and Participation Plan. At least 2 individuals attended the events. Decrease
- Number of newsletters/publications. Delivered more than 900 quarterly newsletters. Distributed all MPO products electronically via website for easy access. Decrease
- *Number of staff speaking engagements*. VLMPO staff was the featured speaker at more than 9 events. **Decrease**
- Attendance at public meetings. Staff attended more than 30 events/meetings to represent the VLMPO. Increase
- Number of media engagements. Local media reported or featured VLMPO activities at least 13 times. Increase

Strategy 2: Provide the public and others with early, ongoing and meaningful opportunities for involvement in the transportation planning process.

### Performance measures:

- Frequency of contact with the public. Over the past year, the VLMPO has made at least weekly updates to our social media websites and regular updates to our main website. Decrease
- Response to public comments. The VLMPO formally responds to all comments received during a public comment period and responds to other comments throughout the year.
   Steady
- Accessibility of staff to public. The VLMPO staff is available to the public during regular business hours, during open houses, at other public events and on social media websites where staff can respond outside of regular business hours.
   Steady

Strategy 3: Maintain timely contact with key stakeholders and the public through the transportation planning process.

### **Performance measures:**

- Number of stakeholder meetings. The VLMPO held at least 2 stakeholder meetings in FY2017, mostly related to the Chamber of Commerce-led Downtown Truck Traffic study.
   Decrease
- Number of public meetings/events. The VLMPO hosted 15 public committee meetings and/or open houses in FY2017.
   Increase
- Number of notices sent to resource and partner agencies. The VLMPO sent about 100 notices to resource and partner agencies. Decrease
- How stakeholder issues were addressed in planning documents. The VLMPO responded to all formal comments received during public comment periods. Steady
- Accessibility of technical information. The VLMPO has continued to develop new tools in FY2017 to allow key stakeholders more access to transportation project data through our project database and websites. This will continue to be an important resource as we implement the 2040 Transportation Vision Plan. Steady

Strategy 4: Identify, involve and mitigate impacts on traditionally underserved communities (those communities with high concentrations of minority, low-income, elderly or disabled populations) in the transportation planning process.

### **Performance measures:**

- Frequency of outreach to traditionally underserved populations. The VLMPO continues to provide information about DBE training offered by GDOT and other planning partners throughout the state. Steady
- (As above.) The VLMPO continues to update our mailing list to ensure all interested parties are included. **Increase**

- (As above.) The VLMPO has met regularly in the past year with representatives of minority communities to address transportation issues and concerns. Steady
- Number of public meetings; accessible location of public meetings. The VLMPO hosted at least 19 hours of public meetings, all at accessible locations. Decrease
- Several new quantitative measures are being developed for FY2017 and will be reported in future annual reports.

Strategy 5: Employ visualization and outreach techniques to better describe and communicate metropolitan transportation plans and processes to the public.

### **Performance measures:**

- *Number of published documents.* The VLMPO published 7 documents in FY2017. **Increase**
- Number of different outreach techniques. The VLMPO employed a number of different outreach techniques in FY2017 including: town hall meetings, interviews, media outreach, open houses, newsletters, social media and websites, presentations, etc. Steady

Strategy 6: Implement goals of the Greater Lowndes County Common Community Vision that promote open, transparent and engaging public participation.

### Performance measures:

- Participation in regional, cross-jurisdictional meetings. The VLMPO participated in at least 15 regional and cross jurisdictional meetings in FY2016. Increase
- Number of active transportation-related partnerships with the VLMPO and local governments. No formal transportation partnerships have been established at this time.
- Number of documents/reports promoting transportation and economic development. The Valdosta Urbanized Area Transit Implementation Report and the City of Valdosta Traffic Signal

Optimization Study both looked at the economic impact of transportation investments on the region. **Increase** 

The SGRC and VLMPO website (www.sgrc.us) is a community resource for everything transportation related. All documents, reports, agendas, minutes, etc. produced by the VLMPO staff are made available on this website for the public and planning partners to use and learn more about transportation in the community. # Pilot Shuttle Program

During its nearly 15 months in operation, the Valdosta Pilot Shuttle Program served more than 1,200 citizens, on 14,723 trips, while traveling over 67,000 miles. This information along with other details of the Pilot Program are documented in a report about implementing public transit in the Valdosta Urbanized Area the VLMPO released in March 2017. This report found that the Pilot Shuttle Program had a benefit to cost ratio of 1.01:1 and that if a recommended public transit system were implemented it could have economic returns for the community greater than 2:1.

This report compared the Valdosta Pilot Shuttle Program to other urban transit systems in Georgia and found that the Pilot Program was similar in several areas like operating costs, while delivering less trips over fewer miles.

During the Pilot Shuttle Program operation, the service won 3 awards: National Association of Development Organizations Excellence in Regional Transportation Award, National Association of Development Organizations Innovation Award, and the Georgia Transit Association Innovation Award.

### Downtown Truck Traffic

The VLMPO in partnership with the Valdosta-Lowndes County Chamber of Commerce and GDOT continued to research and talk about alternatives to remove truck traffic from Downtown Valdosta. Throughout FY2017, the Chamber hosted several meetings with key stakeholders to better understand the issue and propose alternatives to resolve the issue. Based on this input and research a new alternative has been selected for further study. The Gil Harbin Industrial Boulevard Alternative primarily uses this industrial corridor to connect St. Augustine Road in the west to Inner Perimeter Road in the east. The VLMPO is continuing to work with GDOT to further study this corridor.

# **Current Project Status**

One key function of MPOs is to develop a Transportation Improvement Program (TIP) that prioritizes projects for funding by phase (engineering, right-of-way, construction, etc.) over a short-term, four-year period. The VLMPO FY15-18 TIP has been amended several times to keep projects current and moving forward through the process from design and engineering plans to construction. With the adoption of the 2040 Transportation Vision Plan, the VLMPO continues to track the current status of projects in the region.

# Active, Healthy Lifestyles Report

The 2040 Transportation Vision Plan included an Active, Healthy Lifestyles Strategy to "encourage each local jurisdiction to implement at least \$500,000 annually in bicycle and pedestrian infrastructure and/or promote active, healthy lifestyles" in the community. The strategy includes other requirements and criteria that allow smaller communities to make smaller financial investments. Below is the first report on this strategy for local communities.

**Berrien County** – No activities to report at this time.

**Brooks County** – The Brooks County Chamber of Commerce held a 'Summer Slim Down' challenge where they encouraged community teams to lose the most weight.

Lanier County - No activities to report at this time.

**Lowndes County** – Installed sidewalks on Copeland Road at a cost of \$107,000.

City of Dasher – No activities to report at this time.

City of Hahira - No activities to report at this time.

**City of Lake Park** – No activities to report at this time.

City of Remerton – No activities to report at this time.

**City of Valdosta** – The City installed sidewalks on Griffin Avenue, Martin Luther King Drive, South Troup Street (includes bicycle lanes), Williamsburg Drive, and Lake Park Road at a cost of more than \$2.3 million.

## Complete Streets Suitability Report

The 2040 Transportation Vision Plan recommended that the VLMPO measure existing roadways and how "complete" they are according to existing Complete Streets strategies and recognized best management practices. The culmination of this measurement was the National Association of Development Organizations 2017 Innovation Award winning Valdosta and Lowndes County Complete Streets Suitability Report.

"Complete Streets" are those corridors that not only meet the needs of automobiles and other motorized vehicles, but also include amenities cvclists for and pedestrians, regardless of ability. This Report explores the existing transportation infrastructure in the City of Valdosta and Lowndes County to determine which corridors are most suitable for bicycle additional lanes, sidewalks, and other Complete Streets attributes. The results of

this Report were two separate, prioritized lists of corridors suitable for Complete Streets projects for the City of Valdosta and Lowndes County.

# **Planning Studies**

Kimley-Horn as a consultant under contract with the SGRC/VLMPO on behalf of the City of Valdosta completed a project to perform Traffic Signal Optimization and Operational Analysis for 44 traffic signals in the City of Valdosta. The study also included the GIS mapping of the city-owned fiber optic network.

As a part of the analysis the consulting team evaluated actual and historical traffic conditions throughout the study area. The team made recommendations to change various traffic signals and other operational improvements such as restriping turn lanes and intersections and adding turn lanes at other intersections.

Annual Cost Savings: \$3,357,000. Benefit-Cost Ratio of 35:1. The project pays for itself every 7.2 workdays once implemented.

If all of the traffic signal optimizations are made as recommended by the consultant team, the community will see daily vehicle-hours of travel reduced by 770 hours; daily fuel consumption reduced by 790 gallons; daily pollutant emissions reduced by 2,120 pounds of VOCs and NOx; annual fuel and time savings of \$3,357,000. With an estimated cost to implement the traffic signal optimizations of \$97,000, the annual benefit to cost ratio of this project is nearly 35:1, Expressed in another way, the new timing plans pay for themselves approximately every 7.2 workdays.

Intersections that would see the most improvement (if all recommendations are completed) include (with delay reduction in seconds):

- Ashely Street at Smithbriar Drive (111.7)
- Inner Perimeter Road at Forrest Street (40.6)

- N Valdosta Road at Oak Street Extension (30.6)
- Patterson Street at Northside Drive (30.1)
- Baytree Road at Gornto Road (25)
- St. Augustine Road at Gornto Road (19.5)
- Eager Road/Jerry Jones Drive at Country Club Drive (19)
- Baytree Road at Norman Drive (18.2)
- Hill Avenue at I-75 Northbound Ramp (18.1)

The VLMPO will continue to work with City of Valdosta and GDOT to implement these recommendations in future transportation plans as funding is available.




Figure 5 Crashes by Year 2012-2016




Figure 6 Percent of Crashes with Injury 2012-2016




Figure 7 Pedestrian Injuries and Fatalities, 2012-2016




Figure 8 Percent of All Crashes with Seat Belt Use Recorded, 2012-2016

# Financial Highlights

The VLMPO expends funds through projects that are identified in the Unified Planning Work Program (UPWP). The UPWP identifies and outlines the planning activities which the MPO plans to undertake for the following year. The VLMPO received its funds through federal and state grants and local matching funds in FY2017. Federal funds make up a majority of the revenues at 80%, with state funding at 1.6% and the local matching funds at 16.8%. In FY2017, the SGRC started contributing funds to the VLMPO budget as well on behalf of the City of Valdosta and Lowndes County, that share accounted for 1.5% of the total budget. In FY2017, significant additional funds were budgeted and expended to complete the City of Valdosta Traffic Signal Optimization Study, for which the City of Valdosta provided the total match amount.

This chart is a breakdown of the Budget and Actual Expenditures of FHWA PL, and FTA 5303 Funds utilized by the VLMPO in FY2017.




Figure 9 Historical Budget vs Actual Expenditures, by revenue source




Figure 10 Annual Average Revenue FY2011-2017




Figure 11 FY2017 Federal, State, Local, SGRC Share, %




Figure 12 FY2017 Expenditures, by UPWP element, %

Projects that may be considered for evaluation include, but are not limited to: North Lowndes County East-West Connectivity, Downtown Valdosta Removal of One-way Streets, and Five Points Area. Maintain the VLMPO 2035 Joint Land Use Study Travel Demand Model for analysis requests from local stakeholders as it relates to the mission of Moody Air Force Base and its impact on land use and transportation relationships in the Metropolitan Planning Area.

Continue to work with local and state jurisdictions to implement the Bike/Ped Master Plan. Report on the status of this implementation. Explore options for: improved data on bicycle and pedestrian usage in the region (fitness apps, etc.); funding bicycle and pedestrian projects (social impact bonds, crowdsourcing, etc.); improving transportation planning so that it can be used to improve health of the local population. Develop report on local jurisdiction compliance with 2040 TVP Active, Healthy Lifestyles Strategy Implementation. The VLMPO will continue to encourage multimodal transportation facilities that are affordable and accessible and promote active, healthy lifestyles. Ensure that all populations (people and freight) have access to essential services regardless of mode. With other SGRC transportation planning programs, coordinate efforts on Safe Routes to School participation, regional bicycle and pedestrian planning activities (like: complete streets workshops, health and transportation, etc.) and Teens in the Driver Seat programs throughout an 18-county region. Freight and Intermodal Activities: Continue to integrate freight and goods movement planning and analysis into long and short range planning efforts. Work with Valdosta State University Logistics Program on student projects (like: study of commodities, evaluation of truck/rest stops, development of VLD Regional Airport, Import/Export analysis through GA and FL ports, demand for small intermodal facility, etc.). Implement recommendations (if any) from FY2016 Truck Traffic Study. Continue to update data and perform analysis of how freight and goods movement impacts economic development in the region. Coordinate MPO planning efforts with other local transportation modes: railroads, airports, seaports, etc. to inform and influence the LRTP process.

### Quarter 1 Report:

Staff completed work on the Downtown Valdosta Truck Traffic Study with the assistance of Cambridge Systematics. The final report was published on

our website in August. Staff met with community business leaders to discuss the truck study recommendations and presented the alternatives to stakeholder groups.

Continue to develop an Annual Crash Report that analyzes crash data for local governments to identify safety improvements that can be implemented through new projects or educational programs. Conduct Road Safety Audits (RSAs) with local jurisdictions as requested to identify solutions to safety and operational concerns. Encourage and advise local governments to develop transportation asset management plans. Report on age and structural integrity of bridges in the region to highlight need for replacement, ongoing maintenance, future financial needs for repair/maintenance, etc. Develop GIS-based report that evaluates roadways in VLMPO Planning Area against requirements of the Complete Streets Strategy in the 2040 TVP. Continue to work with GDOT and local jurisdictions on the implementation of Intelligent Transportation Systems and architectures in the Metropolitan Planning Area. Coordinate data development and analysis with GIS resources to better visualize data for local decision makers for various MPO plans and projects. Identify data needs to implement MAP-21 Performance Measures and the 2040 Transportation Vision Plan as required and in consultation with GDOT. Collect and analyze data as it is identified to develop data trends and targets for project selection and prioritization. Continue to report on various data trends (VMT, VHT, etc.) that impact transportation planning in the region. Continue to explore new and innovative funding opportunities (unique grants, social impact bonds, etc.) for transportation improvements. Consider using FHWA's PlanWorks tool to help guide and improve the next TIP update. The VLMPO will consider and document methods that consolidate the TIP and LRTP documents and update processes. Develop a framework in the TIP to track and implement performance measures in consultation with GDOT and local planning partners.

Identify data sources needed to implement performance measures as identified in MAP-21 regulations in consultation with GDOT. Monitor the implementation of the 2040 Transportation Vision Plan through the MPO annual report and other reporting methods. Develop GIS layers and models needed for development of land use patterns for travel demand model. Continue to develop reports and information to fund transportation and transit improvements throughout the region. Continue to work with various stakeholders to implement land use policy recommendations from the JLUS study for Moody AFB and surrounding areas. Continue to work with GDOT and local partners in prioritizing and implementing projects in the LRTP and TIP, this includes attending meetings and conducting analysis where needed for a comprehensive, coordinated and continuous regional Long Range Transportation Plan. Continue to inform the public and stakeholders of the Greater Lowndes County Common Community Vision and promote its use as a strategic vision for the community.

### Quarter 1 Report:

Staff prepared an amendment to the 2040 Transportation Vision Plan (see also, Public Participation and TIP elements), the amendment was adopted at the July Policy Committee meeting.

Continue to evaluate the accessibility and mobility of regional activity centers and the various population groups (focus on EJ areas) throughout the region and the impact various transportation modes might have accessibility and mobility.

### Quarter 1 & 2 Report:

Staff carried out the functions of the VLMPO. Staff continued to work on transit implementation reports for the Valdosta Urbanized Area. A final report will be developed once the Valdosta Pilot Shuttle is complete.

### **Quarter 3 Report:**

Staff carried out the functions of the VLMPO. Staff continued to work on transit implementation reports for the Valdosta Urbanized Area. A final report will be developed once the Valdosta Pilot Shuttle is complete. Staff completed a 3 Chapter report on Valdosta Transit Implementation including the summation of the Pilot Shuttle Program, Benefit Cost Analysis and funding for operations/implementation analysis. Report published April 2017.

### 2017-4.4 Special Transportation Studies

### Objective:

To conduct planning level analysis of alternatives for transportation projects identified in the LRTP or by the transportation planning process.

### **Project Description:**

The City of Valdosta propose to study the coordination of traffic signal timings for 38 intersections within the City. This study will promote the efficient management and operations of the regional traffic signal system and major roadway corridors through signal coordination. This study will promote energy efficiency and air quality by minimizing idling time at intersections, and will promote efficient operation of the City's transportation system. This study is supported by goals in the 2040 Transportation Vision Plan to promote an efficient transportation system (18) that is safe and promotes economic vitality (3). The study will recommend Intelligent Transportation System improvements for signalized intersection operations and maintenance as well as optimization of the City of Valdosta fiber optic network. The project will include review and evaluation of existing travel conditions, existing signal equipment and capabilities, pedestrian requirements, real and perceived problems timing plans, data collection, and mapping of the City of Valdosta fiber optic network. Products will include: maps of the entire fiber optic network, recommendations for maximizing efficiency of fiber optic network needs, signal timing plan and database development and testing, and other recommended improvements.

#### Quarter 1 Report:

No work at this time. An amendment to the UPWP is anticipated for December 2016.

### Quarter 2 Report:

No time charged (see UPWP), Staff prepared RFP for Traffic Signal Project.

### **Quarter 3 Report:**
